# Summary for AGM 2023





- Members approved an increment of share capital by Ksh. 15,000 per member within the next 3 years (Ksh. 5,000/- per year from 2023 to 2025). Members are encouraged to save more than the minimum amount approved by the AGM towards their share capital in order to enjoy high returns.
- Members approved borrowing power to remain at Ksh. 1.4B and authorized the board to charge the Sacco's asset where applicable.





### **Total Assets**






### **Deposits**




### **Share Capital**





### **Total Expenditure**




### **Return On Deposit (Interest)**

Mobile loan (M-cash) available 24/7


Special loan payable in 12 years at affordable interest rate of 1.2% per month on reducing balance. Cheapest in the market.

Security for loans include guarantors, title deed, log-book and deposits

Karibu loan available for new members after contributing (2-6 months)



# Process of using collateral for loan



Note: The entire process takes between 1-2 months depending on the location of the land/asset and the quick response of the loan applicant



# **Savings Products**







- Earns interest and determines maximum amount to borrow or guarantee
- Interest rate 2023:
  10.2%
- Minimum Ksh. 4,000 per month



- Ownership of Balozi
- Dividend rate 2023:
  20%
- Minimum share capital- Ksh. 40,000 but is to increase yearly by Ksh. 5,000 for 3 years
